Artwork that contains inappropriate materials, unauthorized photographs of people and children, and other logos/trademarks will be disqualified. Please see full list of rules below.

The winning photographs will be produced and utilized in the 2020 Straub Wildlife Calendar and be distributed to industry partners and customers of Straub Brewery Inc. in October/November 2019.

## OFFICIAL RULES - NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

**TIMING:** The "Straub 2020 Wildlife Calendar Contest begins on Wednesday, July 10, 2019 at 9:00 am. (all times are Eastern Time) and ends on Sunday, August 11, 2019 at 11:59 p.m. ("Contest Period"). At the end of the Contest Period, submitted calendar photographs will be judged and one Grand Prize winner will be featured on the front cover of the calendar. Another 12 winners will be featured on the inside of the calendar 1 winning photograph per month of the year. Names of photographers will be printed next to their pictures in the calendar.

**ELIGIBILITY:** Contest is open only to legal residents in Pennsylvania, who are 21 years of age or older as of the date of entry.
